SANDAG's transportation plan headed for three weeks of public hearings

A series of seven public workshops and hearings will be held between early next week and June 21 focusing on the Draft 2050 Regional Transportation Plan released in April by the San Diego Association of Governments.

The workshops will allow for public input on SANDAG's \$196 billion, 40-year vision for San Diego's transportation infrastructure.

Five of the gatherings will include workshops and take place remotely around the county, while the other two will be held during regularly scheduled agency meetings. Next week's schedule includes public workshops at the following locations: Encinitas Community & Senior Center on Tuesday; The Joe & Vi Jacobs Center in San Diego on Wednesday; and Sonrise Community Church in Santee on Thursday.

Additional regional workshops will be held on Monday, June 13 at the Martin Luther King Jr. Center in National City and Thursday, June 16 at the San Marcos City Council Chambers.

All of the scheduled regional workshops will be held from 4 to 7 p.m., with the public hearing portion beginning at 6 p.m.

Stand-alone public hearings are scheduled for 10 a.m. June 10 at the regularly scheduled SANDAG board meeting downtown, and 4 p.m. June 21 at the San Diego Caltrans office, located at 4050 Taylor St., during the Regional Planning Stakeholders Working Group meeting.
