Applicant-Initiated Action Items

- Rosecrans Lofts CDP & NDP (Process 2) Project No. 644874, Zone CC-4-2, 1333-1355 & 1357 Rosecrans Street. Coastal Development Permit, Neighborhood Development Permit and Variance to convert 13 existing offices on the 1st and 2nd floors of 2 existing commercial buildings to residential apartments and to construct a trash enclosure on the right of way on Emerson Street on a 0.2 acre site. Coastal (non-appealable) & Community Plan Implementation Zone (CPIOZ)—B overlay zones. Transit Priority Area. Applicant: Dean Wilson. Motion made by Mark Krencik, seconded by Don Sevrens. PASSED- unanimous (11-0-0).
- 2. Alsina Companion Unit CDP, (Process 2) Project No. 661159, Zone RS-1-7, 865 Albion Street. Coastal Development Permit for the conversion of an existing 1,027 SF attached guest quarter to a companion unit located on the second floor of an existing single family residence on a 0.24 acre site. Coastal (non-appealable) overlay zone. Applicant: Will Stout. Motion made by Margaret Virissimo, seconded by Robert Tripp Jackson. PASSED- unanimous (10-0-0) (Sarah Alemany had left the meeting by this time).
- 3. 2806 Jarvis Street Condos CDP, SDP & TM, (Process 5) Project No. 661483, Zone RM-3-7, 2806 Jarvis Street. Coastal Development Permit, Site Development Plan and Tentative Map for a public right-of-way vacation to demolish three residential units and construct five new two-story residential condominium units with enclosed parking garage below and rooftop deck on a 0.16 acre site. Coastal (non-appealable), Community Plan Implementation Zone (CPIOZ)—B, Coastal Parking Impact and Transit Priority Area overlay zones. Applicant: Darian Radic. Motion made by David Dick, seconded by Brad Herrin. PASSED- unanimous (10-0-0).
