General

The meeting was called to order by Margaret Virissimo at 6:05 pm.

NON-AGENDA PUBLIC COMMENT

Joe Guilmet is a resident who has children attending The Rock school and is concerned about the installation of the 5G towers at The Rock church. He is concerned that this was done by the church with no approval from the school community. They are concerned about the impacts the 5G tower will have on the health of the children of the school.

Laura Buckley has 3 children attend The Rock Academy and she is concerned about the installation of the 5G towers at The Rock church. There are 6 schools nearby. The direction of the antennas points towards HTH Schools playground area. She does not feel they have properly reviewed the permit request and the health impacts to the school children. They are asking the board for help. There is a group called STOP 5G and they have over 750 signatures at the moment. There was a written mandate sent to the city on behalf of this issue. Project Review has not been contacted to approve these towers.

Margaret Baird is a grandparent who is a disability rights activist who wants to stop the installation of 5G towers. She feels the permit was issued in error. She has been disabled due to the impact of 5G towers. She is a cancer survivor and any reading over a certain level of MHZ will impact her health. She is concerned about the health impacts to the students and staff.

Jennifer Bruce is a parent of a student and attends The Rock church. She asks that the 9 antennas be removed, and the installation of the towers be stopped. She is concerned that the necessary reviews were not completed before the installations were improved.

Tiffany Fletcher has children who attend The Rock Academy and is concerned that T-Mobile as authorized to install 9 cell antennas on the roof of the school. She is concerned that the children will be radiated from the towers.

Korla Eaquinta mentioned that due to the new CPG rules all board members will be required to submit their bio and complete the E-Cow Training to keep us compliant with the new CPG rules.

GOVERNMENT AND COMMUNITY REPORTS

Margaret Doyle provided update from Assembly member Tasha Boerner. She is part of the committee who is in the process of auditing SDGE rate increases.

Randy Reyes provided update from City of San Diego Council District 2, Dr. Jennifer Campbell. The VHO/Homeless encampment ordinance went into effect on April 1st. It passed through committee and will be considered by the city council soon.

Street light repair Loma Portal lights will be included in the light package funding secured for 200 streetlights to be repaired.
